CCPCJ convenes 26th session

201911

The <u>26th regular session of CCPCJ</u>, held from 22 to 26 May 2017 in Vienna, was attended by 1000 representatives from Member States, UN entities and other international

organizations, and civil society. In addition to the annual thematic discussion, participants discussed a number of standing items, including efforts by the UNODC and Member States in the field of crime prevention and criminal justice, the use and application of UN standards and norms, world crime trends and emerging issues and responses. Over 90 side events and 10 exhibitions were held during the meeting.



PNI workshop



The United Nations Crime Prevention and Criminal Justice Programme Network (PNI) holds annual workshops during the regular CCPCJ sessions. The theme for the 2017 workshop was <u>"Institutional</u> <u>coordination in crime prevention: international perspectives"</u>, and featured experts sharing their experience on national crime prevention strategies for children and youth, rehabilitation programmes and coordination mechanisms for crime prevention and criminal justice in different parts of the world.

Preparations for 14th UN Crime Congress



The 14th UN Congress on Crime Prevention and Criminal Justice will be held in Japan in 2020. The congresses, held every 5 years, bring together States, intergovernmental organizations and individual experts and have influenced policies and practices on crime prevention and criminal justice for over 60 years. As decided at the 26th CCPCJ session and approved by ECOSOC for adoption by the General Assembly, the theme of the Congress will be "Advancing crime prevention, criminal justice and the rule of law: towards the achievement of the 2030 Agenda". It also decided on the agenda, workshop topics and that the Congress would adopt a single declaration to be submitted to CCPCJ for consideration. In October, UNODC and Japan's Mission to the UN also organized a briefing in New York on preparations underway. Regional preparatory meetings are planned to take place in 2019.

Mission of CCPCJ Chair to ECOSOC



H.E. Ambassador Mitsuru Kitano (Japan), Chair of the 26th CCPCJ, attended ECOSOC's Coordination and Management meeting, held 6-7 July in New York, to present the highlights of the 26th CCPCJ session and describe how the Commission contributes to the work of ECOSOC, in particular to the implementation of the Sustainable Development Goals (SDGs). He stressed the key role of promoting the rule of law, a core function of CCPCJ, in the achievement of the SDGs.

CCPCJ collaboration with CSW



In the context of GA resolution 70/299 on the follow-up and review of the 2030 Agenda for Sustainable Development at the global level, the CCPCJ is strengthening its partnership with other functional commissions, in particular with the Commission on the Status of Women. At the 2017 High-Level Political Forum held in July in New York, CCPCJ and CSW held a joint event to highlight the linkages between gender equality and the empowerment of women, and crime prevention and criminal justice matters.
