Jakarta Statement on Anti-Corruption Agencies and Kuala Lumpur Statement on Anti-Corruption Strategies

In November 2012, the Corruption Eradication Commission of Indonesia (KPK) together with UNDP and



UNODC brought together heads of several anti-corruption agencies and experienced practitioners from around the globe who developed a set of principles on anti-corruption agencies, the Jakarta Statement on Principles for Anti-Corruption Agencies. In October 2013, the Government of Malaysia, together with UNODC and UNDP, invited high-level officials from planning and anti-corruption authorities from across Asia who elaborated guidelines for the process, content and implementation mechanism of anti-corruption strategies, the Kuala Lumpur Statement on

Anti-Corruption Strategies. Both statements were extensively referred to in presentations and in special events during COSP, were distributed as conference room papers and were reflected in Resolution 5/4 "Follow-up to the Marrakech declaration on the prevention of corruption."

Launching a study on match-fixing and illegal/irregular betting



At a special event during the fifth session of the Conference of the States Parties, a study on "Criminalization approaches to combat match-fixing and illegal/irregular betting: a global perspective" was officially presented as a joint project of UNODC and the International Olympic Committee. The study was very well received as a first step towards improving Member States' response to the problem. It compiles relevant criminal legal provisions from various countries in different regions, identifying discrepancies and similarities, and thereby suggests guiding principles and model provisions for creating

and/or updating relevant offences to facilitate international cooperation. At this special event, the Russian Federation also presented their proposal to create a multi-stakeholder global alliance for integrity in sports and UNODC launched a handbook entitled *The United Nations Convention against Corruption: a Strategy for Safeguarding against Corruption in Major Public Events.*

UNODC delivers customized training to Saudi experts

As part of its capacity-building activities, UNODC organized a three-day customized training for Saudi government officials and experts participating in the Implementation Review Mechanism for the UNCAC in collaboration with the Saudi National Anti-Corruption Commission (Nazaha). The training, which took place in Riyadh 7 to 9 October 2013, included the judiciary, Public Prosecution, Ministry of Interior, Ministry of Foreign Affairs, SAMA (Saudi Arabian Monetary Agency), Board of Grievances, National Anti-Corruption Commission and the



private sector (Council of Saudi Chambers and SABIC - Saudi Basic Industries Corporation). This training helped develop the participants' ability to participate in the UNCAC Review Mechanism and provided participants with the requisite substantive expertise in UNCAC provisions to undergo and perform reviews.

Training Iraqi officials in financial investigation



In the framework of a project supported by the Bureau of International Narcotics and Law Enforcement (INL) at the US Department of State, designed to support Iraqi efforts to ensure effectiveness in the fight against corruption by strengthening adherence to UNCAC standards, UNODC, in collaboration with the Iraqi Commission of Integrity, conducted two training courses for Iraqi national authorities on "financial investigations in support of asset recovery," held in Baghdad 9 to 12 September and 11 to 13 November 2013, as part of a series of training sessions to be delivered in 2013-2014.

The training courses were attended by officials from the judiciary, the Commission of Integrity, Ministry of Interior, Financial Intelligence Unit and the Central Bank addressing practical aspects of financial investigation, tracing funds, linking money to the crime and perpetrator(s), as well as aspects of international cooperation regarding freezing, confiscation and recovery of assets.
