Victim-Centred **Approach**

The Trust Fund Approach is based on the "3P" paradigm of the Trafficking in Persons Protocol.

Protection: Immediate humanitarian assistance for victims. Prosecution: Access to justice, legal advice and assistance.

Prevention: Necessary empowerment and support for the victims' personal autonomy.

MISSION:

Administered by the United Nations Office on Drugs and Crime (UNODC), the United Nations Voluntary Trust Fund for Victims of Trafficking in Persons UNVTF's mandate is to provide humanitarian, legal and financial aid to victims of

trafficking in persons through the awarding of multi-year grants to existing channels of assistance, implemented by governmental, intergovernmental and non-governmental organizations.

In August 2010, Member States of the UN General Assembly established the Trust Fund as an integral component of a global effort to address trafficking in persons.

KEY FACTS:

What is Human Trafficking? Under the Protocol to Prevent, Suppress and Punish Trafficking in Persons, Especially Women and Children, Trafficking in Persons is defined as "the recruitment, transportation, transfer, harbouring or receipt of persons, by means of threat or use of force or other forms of coercion, of abduction, of fraud, of deception, of the abuse of power or of a position of vulnerability or of the giving or receiving of payments or benefits to achieve the consent of a person having control over another person, for the purpose of exploitation. Exploitation shall include, at the minimum, the exploitation of the prostitution of other or other forms of sexual exploitation, forced labour or services, slavery or practices similar to slavery, servitude or the removal of organs".

What is the objective of the Trust Fund? The UN Trust Fund supports actions by specialized NGOs around the world that ensure that women, children and men who have been exploited by human traffickers are identified, treated humanely as victims of a crime, and provided with the assistance, protection and support necessary for their physical, psychological and social recovery and reintegration back into their communities. Emphasis is given to providing access to justice, legal advice and assistance, including for victims to claim access to remedies, compensation or similar aid packages. UNVTF seeks to prevent trafficking in persons, and to reduce the vulnerability of victims being discriminated, re-victimized and re-trafficked.

How is the Trust Fund helping victims of human trafficking? In its first grant cycle (2011-2014), 11 NGOs from across the globe were selected and awarded

grants for up to three years, totalling US\$ 750,000. In the second call for proposals, launched in 2014, against trafficking in persons grants were disbursed to 23 NGOs totalling US\$ directly supports the work 1.25 million for projects over a three-year cycle ending in 2017. In 2018, US\$ 1.5 million will be given in grants. The priority of the third call for proposals impact on society. Donations is focused on projects assisting victims coming out to the Blue Heart Campaign of a context of armed conflict and those identified among movements of refugees and migration flows.

The Blue Heart Campaign of the Trust Fund as a global awareness raising initiative to fight human trafficking and its go directly to the Trust Fund.

Who is contributing to the Trust Fund? As of April 2018, the Trust Fund has received US\$ 4.2 million in contributions from a wide range of supporters. These include 30 Member States, 31 private sector organizations and scores of individual donors. Before 2017, the average level of contributions per year since 2010 had been US\$ 360,000. The Board of Trustees of the Trust Fund, as well as an independent evaluation have confirmed an annual funding target of US\$ I million as the minimum requirement needed to ensure a sustainable and effective functioning of the Trust Fund. In 2017, the Trust Fund witnessed a substantive increase in donations: a total amount of US\$ 1.66 million was deposited. As a result, the the average level of contributions per year since 2010 has risen to US\$ 520,000 thanks to the generous support of our partners.
